Sections 242(1)(a), 249, 256, 257 & 264*

- ◆ A reference can be made to the Mental Health Court if there is reasonable cause to believe a person alleged to have committed an indictable offence—
 - ◆ is mentally ill or was mentally ill when the alleged offence was committed;
 - ◆ has an intellectual disability of a degree that issues of unsoundness of mind, diminished responsibility or fitness for trial should be considered;
- ◆ This reference can be made by—
 - ◆ the person or the person's legal representative; or
 - ◆ the Attorney-General; or
 - ◆ the Director of Public Prosecutions; or
 - ◆ the Director of Mental Health.
