Court practice notes

Criminal Arrests / Bails callover: Adult arrests, Notices to Appear and summons by police.

Childrens Court callover: All arrests, Notices to Appear, summons and applications relating to children including Child Safety applications.

Domestic Violence: Applications for Temporary Protection Orders (before service) as arranged with the court. Domestic Violence callover - all applications for Protection Orders and Variations/Revocations.

General callover: State and local government prosecutions, complaints under Peace and Good Behaviour Act, Property Law Act and other miscellaneous matters not covered by a specific callover.

Commonwealth callover: All Commonwealth Prosecutions including applications to change child's name and Chamber applications.

Traffic / Transport callover: Summonses and applications under Transport Operations Acts and Related Regulations.

Queensland Civil and Administrative Tribunal (QCAT) Claims listed by registry. Uniform Civil Procedure Rules (UCPR) trials and applications listed by registry.
