Court Practice Notes

Summer Court Closure:
 Richlands Court will close at 4:30pm Wednesday 24 December 2025 and will re-open on Monday 05 January 2026. There will be no court sittings during this period.

Bail undertakings and notices to appear:
 These matters are to be listed for 9:00am on a Monday, Tuesday, Wednesday or Friday.
 All defendants must appear at the first mention whether they are on a bail undertaking or a notice to appear.

Duty Lawyers:
 Duty lawyers are available for adults every day and on Thursday for Children. The Duty Lawyer will also see any child in custody on any other day. An on-call duty lawyer will be available for children in custody on Saturday morning.

Long and complex sentences:
 To avoid delay on busy callover days, matters that are expected to exceed 15 minutes will be allocated a special date and time.

Any schedules and other materials to be relied upon by a party must be filed with the court on the day before the sentence.

General callover includes:
