NOTICE TO ACCOMPANY LIST

(Section 26(1))

Notice is hereby given pursuant to Section 26(1) of the *Civil Proceedings Regulation 2024* that

- (a) a person entitled to the amount mentioned in No. **1, 2, 3, 4** of the list may apply under section 27 to the Court or a Justice of the Supreme Court at Brisbane, on or before **16 May 2025** for an order for the payment of the money or securities.
- (b) if an application is not made under paragraph (a), an order may be made that -
 - (i) in the case of an amount of money - the amount be paid into the Consolidated Fund; or
 - (ii) in the case of a security - the security be sold and the net proceeds of the sale, including any interest that has accumulated on the securities be paid into the Consolidated Fund.
