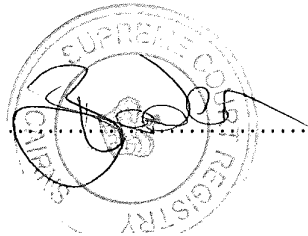
Take notice that the below accounts are inactive under *S30 Courts Funds Regulations 2009*.

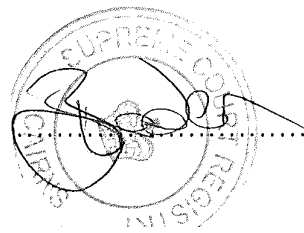
NOTICE TO ACCOMPANY LIST

Notice is hereby given pursuant to Regulation 30(1) of the Court Funds Regulations 1999 that
