Notice is hereby given pursuant to Section 26(1) of the *Civil Proceedings Regulation 2024* that

- (a) a person entitled to the amount mentioned in No. **1, 2, 3, 4, 5, 6** of the list may apply under section 27 to the Court or a Justice/Judge of the Supreme or District Court at Brisbane, on or before **15 May 2026**, for an order for the payment of the money or securities.
