### Court practice notes

**Bail undertakings and notices to appear:**  
These matters are to be listed for 9.00am on a relevant Monday or Friday.

Mid-week in custody matters are to be listed at times arranged with the Registrar or court staff in consultation with the Magistrate.

**Duty Lawyers:**  
Duty Lawyer days are every Monday and Friday.

An on-call duty lawyer will be available for mid-week new in custody matters only at 9.00am on Tuesday, Wednesday and Thursday.

**Long and complex sentences:**  
To avoid delay on busy callover days, pleas that exceed 15 minutes will be allocated a special date and time.

Any schedules and other materials to be relied upon by a party must be filed with the court on the day before the sentence.

**Other matters:**
