2022 Listing arrangements

Arrests court: Daily at 9:30am and 2.15pm in Court 1 Saturday and Public holidays at 8.30am in Court 1.

Childrens Court: Every Wednesday and Friday excluding public holidays at 9:00am in Court 8. As a general rule Children in Custody shall be dealt with first. Children's videolink at 9am Friday. Children's Long Pleas at 9:00am on Tuesday as listed by the Children's Court Magistrate.

Video linkup: Every Monday excluding Public holidays at 9:00am.

Child Protection applications: Every Thursday excluding public holidays at 9:00am in Court 8.

Domestic Violence Court: Every Thursday excluding public holidays at 9:00am, Court 6 and 7. Disputed applications to be set down for separate hearing date. Urgent applications to be heard as arranged with the Domestic Violence clerk.

Commonwealth callover: Commonwealth prosecution matters only. Alternate Tuesday to Miscellaneous callover at 2.15pm, excluding public holidays as listed.

Miscellaneous callover: Alternate Tuesday at 2:15pm, excluding public holidays. Prosecutions by State government departments and Instrumentalities (other than Traffic or Transport matters), Show Cause proceedings under the Penalties and Sentences Act.

Community Corrections callover: Every 2nd Wednesday at 2.15pm as listed, excluding public holidays for Community Corrections breaches commenced by Complaint and Summons or adjournments from Arrest Court.

Long Pleas: Lengthy pleas (i.e. expected to last longer than 20 minutes) before the Arrest Court will be given a Long plea date, commencing at 9:00am and Children's long pleas Tuesday each month at 9:00am.

Restricted License applications: Section 87 TORUM Act applications are to be listed for 9:00am Tuesday in the Court diary in a separate court from Arrests Court.

QCAT and Civil applications: QCAT matters are now listed for 9:00am every Monday as listed. CIVIL applications dates as listed at 9:00am as listed.

QCAT - Minor Civil Disputes: Every second Friday at 09:00am as listed.

Hearing / Committal Callover: Every Wednesday excluding public holidays in Court 6. ATSILS 9.30am, Non ATSILS 2.15pm.

Mental Health: One Wednesday every month at 2:15pm. All matters where it has been indicated by referral to Mental health as listed.

Murri Court: Every second Friday excluding public holidays at 9:00am Youth Murri Court 10am Adult Murri Court.
