



## Naming Convention - Judicial Officers

When referring to Queensland’s judicial officers, the following naming conventions apply.

First names should not be included. Last names should not be used without the appropriate judicial title or abbreviation (for example, Justice Green or Green J; not Green).

Post nominals and the spelling of judicial officers’ last names can be verified on the relevant [judicial profile](#) which can be found on the Supreme Court Library website.
