Subject:	Procedure in applying to access Land Tribunal records

### BACKGROUND

A Chairperson has been appointed to the Land Tribunal to act in a part-time basis from 21 December 2017 up to and including 20 December 2018.

Sections 223 and 231 of the *Aboriginal Land Act 1991* provide general powers for the purpose of a proceeding in relation to a claim, the Land Tribunal may do all other things necessary or convenient to be done or in connection with the hearing and determination of the claim.

### PROCEDURE

Sections 223 and 231 of the *Aboriginal Land Act 1991* provide authorisation to issue forms for use in applications before the Land Tribunal. The Land Tribunal has created an "Originating Application Form" (Form 1) and a "Template Affidavit Form" (Form 2).

If a party is seeking to apply to access records from the Land Tribunal, that party must apply the following procedure:

- 1. File an originating application on the attached (Form 1)
- 2. File an affidavit(s) on the form attached (Form 2) outlining the following:
  - a. what records the applicant(s) seek
  - b. whether the applicant(s) have the consent of a representatives of the original claimant(s) to whom the records relate
- 3. File proof of service with the originating application and affidavit(s).

The Chairperson will decide the application. The Registrar of the Land Court will establish and maintain a record of any applications for access to the records of the Land Tribunal.
