**DISTRICT COURT OF QUEENSLAND**

**NOTICE OF CHANGE OF NAME**

---

1. On 1 March 2021, the name of the firm known as Quinn & Scattini Lawyers changed to Ryan Murdoch O'Regan Lawyers. The firm's service address has not changed.
2. On the basis that the name of the practice forms part of the address for service to which Rule 17(4) of the *Uniform Civil Procedure Rules (1999)* refers, a party to a proceeding who prior to 1 March 2021 had been represented by Quinn & Scattini Lawyers, is hereby relieved of the obligation under Rule 17(3) to file and serve notice of change of the party's address for service consequent upon the change of name from Quinn & Scattini Lawyers to Ryan Murdoch O'Regan Lawyers.
3. For the purposes of the *Uniform Civil Procedure Rules 1999*, as from and including 1 March 2021:
  - a) Service of a document addressed to "Quinn & Scattini Lawyers" at the firm's address at Level 2/102 Adelaide Street Brisbane City, Queensland, 4000, will be taken to be service upon "Ryan Murdoch O'Regan Lawyers at that address;
  - b) Service of a document addressed to "Quinn & Scattini Lawyers" at the firm's address at Level 1/2406 Gold Coast Highway, Mermaid Beach, Queensland, 4218 will be taken to be service upon "Ryan Murdoch O'Regan Lawyers at that address;
  - c) Service of a document addressed to "Quinn & Scattini Lawyers" at the firm's address at 99 George Street, Beenleigh, Queensland, 4207, will be taken to be service upon "Ryan Murdoch O'Regan Lawyers at that address;
  - d) Service of a document addressed to "Quinn & Scattini Lawyers" at the firm's previous address at 141 Shore Street West, Cleveland, Queensland, 4163, will be taken to be service upon "Ryan Murdoch O'Regan Lawyers at that firm's new address at 31 Middle Street, Cleveland, Queensland, 4163;
  - e) Service of a document addressed to "Quinn & Scattini Lawyers" at the firm's address at Shop 1/689 Cusack Lane, Jimboomba Queensland, 4280, will be taken to be service upon "Ryan Murdoch O'Regan Lawyers at that address; and
  - f) A reference in a document filed prior to that date to "Quinn & Scattini Lawyers" is to be taken to be a reference to "Ryan Murdoch O'Regan Lawyers".
4. It will not be necessary for the Registrar to place on the file for any proceeding referred to in paragraph 2, a copy of this practice direction or other notification of the change of name. The publication of the practice direction itself deemed to be sufficient notification of the change.
