Summary Trials are conducted every
4th & 5th Monday, every Tuesday,
every Thursday and every Friday.
Committal hearings including
Committals with cross-examination,
Directions hearings, Applications to
cross-examine, Represented full
hand up committals with
submissions and unrepresented Full
hand up committals are conducted
every 1st, 2nd, 4th & 5th Wednesday.
Committal hearings can be listed on
Summary trial dates as required and
approved by presiding Magistrate.
Represented full hand up
committals without submissions are
conducted in Court 9 on Tuesdays
and Thursdays.
Custody lengthy pleas can also be
listed in a vacated Summary Trial
spot when necessary.
