### PROJECTS

The Court will initiate these projects:

- » Digitise the Queensland Mining Warden's Decisions - The Court will digitise it's collection of mining warden decisions and copies of transcripts, appeal decisions of superior courts and courts of other jurisdictions.
- » Cultural Records Undertake an audit of all Cultural Heritage records and work with Queensland State Archives to develop a culturally appropriate process for both recording and providing access to the evidence given in land claim hearings by First Nations Peoples.
- Audit of Records Undertake an audit of all Land Court records to identify Aboriginal Land Tribunal and permanent records held in offsite storage.

### **INSTITUTIONAL ARRANGEMENTS**

The Court will ensure a review of:

- » **Fee Structure -** The Court will continue to investigate the introduction of a relevant fee schedule for matters being determined by the Land Court of Queensland.
- » Indigenous Assessors Investigate opportunities to engage Indigenous Assessors.
- » Queensland Law Reform Commission Registry to conduct an analysis of Mining Objection
  Hearing applications from 2007 to 2022 to assist with the review.
