## Update on Murri Court evaluation

### Murri Court sites chosen

The Ipsos Aboriginal and Torres Strait Islander Unit (ATSIRU) in conjunction with the Murri Court Evaluation Cultural Reference Group has confirmed that Ipsos will visit Murri Court sites at Mount Isa, Cairns, Cherbourg and Brisbane.

The consultation will occur from October to November 2018. The four sites were selected based on diversity of cultural groups considering:

- the differences between Aboriginal and Torres Strait Islander people, difference between various language groups
- the diversity of the density and access to services in urban centres, regional and discrete communities as well as the variations in the types of organisations contracted to manage the justice group;
- type of court processes and program practices used.

Ipsos will also have a number of in-depth telephone interviews with stakeholders and obtain feedback from across the State. Ipsos want to understand what aspects of Murri Court are most important in getting good outcomes.

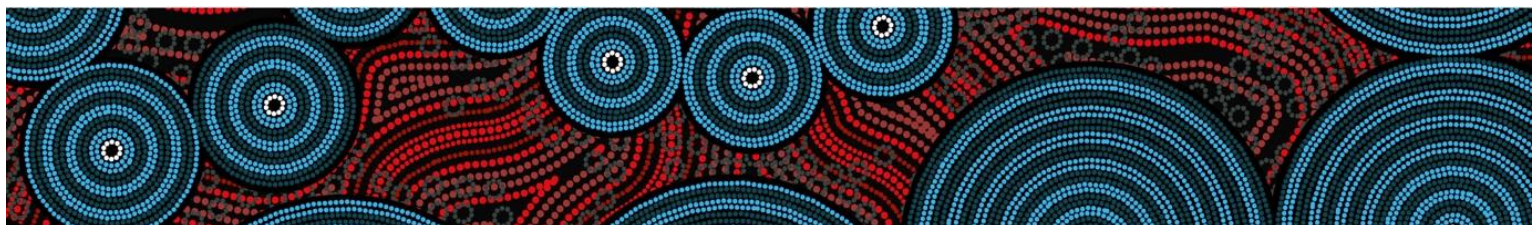
