

President's overview



President Stilgoe OAM


It is a little strange to be presenting my second annual report, given that I only relinquished my training wheels at the end of May.

The Court is now back to its full complement of Members with the appointment of Member Nicholas Loos on 31 May 2024. Member Loos represents a fresh approach to the Court's work: he is the next generation of lawyer and comes from the private Bar. I look forward to working with Member Loos as the Court continues its journey as a modern, efficient Court.

We have had several personnel changes over the past year in both the Judiciary and the Registry. I would like to thank the Members and Judicial Registrar for their continued support and efforts in keeping up with the caseload increases.

I also want to thank Jan Moy for taking on the role of Principal Registrar and leading the Registry with patience and flexibility through the changes over the past 12 months.


Performance



There was a substantial increase in both lodgements and finalisations this financial year. The clearance rate increased, which was an expected and welcome result.

With a steady flow of land valuation appeal (LVA) lodgements throughout the year, the finalisations continued to increase throughout the second half of the year which is typically a time of fewer lodgements. With a higher number of lodgements in the previous financial year, the Court had a larger number of cases to resolve coming into the current financial year.

Appeals numbers of 585 were lodged in the LVA jurisdiction which equates to 89.3% of total filings. The Valuer-General's 2023 valuation program (1 October 2022 date of valuation) saw fewer properties revalued with only 805,000 compared to 1.51 million in the 2022 program (DOV 1 October 2021 date of valuation). These figures demonstrate that the number of valuations doesn't always equate to the number of appeals filed. The increase in this year's filings could be due to large percentage increases in valuation amounts. The Court also continues to experience appeal filings from previous valuation years due to a change in process regarding the Valuer-General's decisions on objections.



Mining resource cases across the board were low in lodgements this financial year.


EPA matters were above average with a combination of objections and appeals against internal review decisions. There was also an increase in referrals of decisions made against PRC Plans.

Acquisition of land cases were slightly lower than average. Categorisation appeals were slightly above average.

Land Act and Land Court Act lodgements remained steady throughout the year.

Although these other jurisdictions have lower numbers of filings, their complexity consumes proportionally more Court time.

Land Appeal Court had slightly more lodgements than usual as 4 appeals were filed against 2 lower court matters.



Active caseload

At the end of the financial year, the Court's active caseload was 136 cases an increase of 0.7% from last financial year. This is a positive result considering the Court's lodgements increased by 40.7%.

Only 7 cases are more than two years old which is only 5% of the Court's caseload.

Finalisations and timeliness

The Court continued its high success rate in Preliminary Conferences (PCs) for LVA appeals under \$5M with 306 settlements. A further 323 LVA appeal cases listed for a PC resolved before any Court event. Clearly, listing an appeal for a PC serves as a trigger for parties to negotiate and settle, saving the parties, and the Court, time and costs.


Seven cases were resolved by private mediation.

The Court heard and determined 20 individual matters.


The percentage of cases resolved within 6 months from the date of filing was 88.64%. This is a slight improvement on last financial year, particularly given the higher lodgement numbers. The average time for finalisation was 106 days (3.4 months).

Clearance rate

The Court's clearance rate for this financial year was 99.4%, an improvement from last financial year. With higher numbers of lodgements, the Court continued to achieve high settlement rates as it finalised 656 files this financial year.

Appeals to the Land Appeal Court and judicial review

The Land Appeal Court (LAC) received 5 appeals this financial year, 4 of which related to 2 matters – *Jensen*¹ and *Namrog*². In June the Court heard *Namrog* in Rockhampton and *Jensen* will be heard in the first quarter of the new financial year. An appeal from BHP Coal Pty Ltd & Ors v Chief Executive, Department of Environment, Science and Innovation [2024] QLC 9 was filed just before the end of this financial year.

The Land Appeal Court determined an appeal in Aurizon concerning both the substantive decision³ and costs of the hearing below⁴.

No judicial review applications were made to the Supreme Court and no appeals were filed in the Court of Appeal.

Land Court of Queensland

The Land Court hears and determines matters relating to land and natural resources and is comprised of a President, Members, and a Judicial Registrar.

The President is responsible for the administration of the Land Court and ensuring the orderly and expeditious exercise of the jurisdiction and powers of the Land Court. Peta Stilgoe OAM was Acting President until being appointed as President on 31 May 2024.

Appointment of President Stilgoe (by Member Loos)

On 31 May 2024, Peta Stilgoe OAM was sworn in as the President of the Land Court. Her Honour had been acting in the role for more than a year.

President Stilgoe has had a distinguished career. Called to the Bar and as solicitor of the High Court of Australia in 1984, her Honour specialised in commercial litigation before her appointment as the first Alternative Dispute Resolution Registrar of the Planning and Environment Court of Queensland (PEC). That position was designed as a 12-month trial but following the success of it, was made permanent. In that position, President Stilgoe was instrumental in designing and implementing court-facilitated mediation in the jurisdiction for expeditious and inexpensive resolution of PEC disputes. The role also involved the trial of the eFiles Pilot Project.

In-keeping with her pioneering penchant, President Stilgoe was appointed as an inaugural member of the Queensland Civil and Administrative Tribunal at its inception in 2009 and then as a Senior Member in 2012. The following year her significant contributions were recognised when she was awarded a Medal of the Order of Australia (General Division) for her services to dispute resolution.

Her Honour was appointed as a member of the Land Court of Queensland in July 2017, bringing the extensive experience and skill which later contributed to the development of this Court's innovative Court Managed Expert Evidence processes. Her Honour remains a sessional member of QCAT.

In dedications written about the President during her notable career, her Honour has been admired as technically excellent, pragmatic, courteous, kind, and a force to be reckoned with. Her Honour's forthrightness is well known. It is a splendid asset, both in and out of Court. In Court, no practitioner or litigant is left unsure of where they stand. Matters before her Honour move swiftly and efficiently.

The Land Court of Queensland is honoured to welcome the President. The Court community looks forward to her Honour's continuation of a strong track record of highly regarded leadership and commitment to fairness, efficiency, and innovation.

Retirement of Fleur Kingham (by President Stilgoe)

It is not difficult to find tributes to the work of former President Fleur Kingham in her roles as a District Court Judge, Deputy President of QCAT, President of the Land Court, and a reformer of practice and procedure. Paul Smith, Former Member of the Land Court of Queensland

Paul Smith, a Member of the Land Court from 2007 until 2019, passed away on 21 November 2023 following a period of prolonged ill-health. Prior to his appointment to the Court, Paul had a significant career in the Public Service commencing as an administrative officer in 1975 and progressing to Executive Director of Native Title Services at Crown Law. During this period Paul had substantial involvement in both the *Mabo* and *Wik* native title proceedings.

Throughout his time at the Land Court Paul was active across the entire range of matters within the jurisdiction, including a strong involvement with statutory valuation appeals, a variety of mining judgements together with Land Appeal Court decisions when required.

In addition to a deep love for his family and a passion for justice, Paul was strongly committed to his voluntary university appointments in the Ukraine. Paul's love of sport and his encyclopaedic knowledge of local history were regularly shared with his work colleagues and friends.

Principal Registrar's overview

As Registrar of the Land Court, I am pleased to report on the activities of the Registry in the past financial year.

In October 2023 I was appointed as the Acting Registrar of the Land Court upon the previous Principal Registrar, Darren Campbell, taking long leave.

I would like to acknowledge the work done by the former President, Fleur Kingham, and Darren Campbell and Registry staff who have worked tirelessly over past years to have the Land Court Registry to where it is today. There have been many improvements and projects undertaken and completed by a small, dedicated team and I will continue to follow the structure and commitment that is now in place. President Stilgoe and I are committed to continuing this great work.



Jan Moy, Principal Registrar

Along with my move to the Land Court this financial year, we have seen other significant changes as well. Acting President Stilgoe was permanently appointed in May 2024, and we welcomed a new Member to the Land Court, Nicholas Loos.

The Registry is continuing to follow the Reconciliation Action Plan (RAP) with all staff regularly attending cultural learning sessions and considering all relationships and alliances when going about our day-to-day business. We will continue to expand our RAP in conjunction with Reconciliation Australia and other government agencies.

Strategic plan

The Registry has been able to complete most items from the 2022-2023 Land Court Strategic Plan. Moving forward, we are now incorporated into the Supreme, District and Land Court Strategic Plan.

Conference 2023

In July 2023, the Land Court and Referring Agencies Annual Conference took place at the Dreamtime Cultural Centre, Rockhampton. The conference was opened with a Welcome to Country and Smoking Ceremony by Caleb Tull and Tarryn Cora of the Darumbul Community Youth Services Inc, followed with a ceremonial corrobboree dance by Jordan Young of Mundagatta Didgeridoos. The conference program featured a range of stakeholders, including former Commissioner for the Royal Commission into the Child Protection and Youth Detention Systems in the Northern Territory, Executive Director Strategic Policy and Legislation, Queensland Law Reform, representatives for the Department of Resources, Environmental and Heritage Policy and Programs Division, and AgForce.

Virtual preliminary conferences

In March this year President Stilgoe initiated a pilot program for virtual preliminary conferences (VPCs). While the Land Court may sit anywhere in Queensland and cases are normally heard in the district where the land that is the subject of the dispute is located, the Land Court now offers a virtual preliminary conference process. This was initially offered to self-represented appellants located outside of South-East Queensland. This process allows for parties to attend a VPC via video conferencing.

Aboriginal Tribunal

The *Aboriginal Land Act 1991* established the Land Tribunal to receive and hear claims made by groups of Aboriginal peoples to areas of claimable land.

The Act contained a sunset clause, which provided no new claims could be lodged after 22 December 2006, and the last claims determined were the Boodjumulla (Lawn Hill) National Park claims, determined in 2016.

However, claims under the Act were lodged with the Department of Resources (as it now is) but have not been referred to the Tribunal. The Land Court President has been appointed Chairperson of the Land Tribunal on a part-time basis to deal with any residual claims.

Librarian's report

Collection of artefacts

The Land Court of Queensland has care of a small collection of First Nations artworks. These were acquired by the late Graeme Neate, Chairperson of the Aboriginal Land Tribunal and Torres Strait Islander Land Tribunal from 1992 until 2001.

Pandanus weavings

There are 2 circular mats — one by Bessie Numarididi — made from fibre of pandanus palm leaves and dyed using roots, bulbs, bark, and ashes. These mats are used as floor coverings, to provide shade, and for carrying.

Woven pandanus objects are a tangible link between the weaver, Country, and ancestors. The vibrant colour of the mats has diminished with time and this year the Court commenced a project to preserve the mats and display them to ensure their longevity.

The Court has 2 wooden Tiwi Island carvings in the style of grave posts used in funeral ceremonies, which are coated in a medium and decorated. The larger carving stands at 90 cm and the smaller one 30 cm.


